#### **IMPORTANT DATES:**

- **July 15, 2018:** Online submission entry deadline. When deadline is reached, the competition is automatically closed to submissions in the www. <http://www.showsubmit.com/program>.
- **August 1, 2018:** Notification of acceptance posted online on NAWA's Facebook page, ([www.facebook.com/TheNAWA](http://www.facebook.com/TheNAWA)), and the NAWA website: [www.thenawa.org](http://www.thenawa.org)
- **Shipped work must arrive at Museum between September 6-10, 2018. All shipped art work MUST have prepaid barcoded return shipping labels included in shipped box, for return of artwork.**
- **Hand delivered work** MUST be received at the Coral Springs Museum of Art, 2855 Coral Springs Drive, Coral Springs, Florida 33065, on September 21, between 10-12noon.
- **Installing Work:** September 21, 2018
- **Exhibit Opens:** September 22, 2018
- **Reception and award presentation:** Thursday, October 18, 2018, 6-8PM
- **Show closes:** Saturday, November 17, 2018
- **Pick up work:** Monday, November 19, between 10am-12 noon
- **Return shipped work:** Monday, November 19, 2018

#### **ENTRY GUIDELINES:**

- Every current regular NAWA member is permitted to enter two (2) original works.
- This is a juried exhibition for entry and also juried separately for awards.
- Works older than 5 years (before 2013) may be exhibited, but are not eligible for prizes.
- Works that have won a prize in previous NAWA shows are not eligible.

- Entry fee \$40 for 2 entries. Fee must be paid by the entry deadline.
- Entry is done through: <http://www.showssubmit.com/>. The entry form must be filled out in its entirety, including Framed Dimensions (enter framed dimensions in both art size and framed size).
- Make sure your image is 1920 pixels @ 72 dpi on the longest side. Images should be in JPEG format, RGB color space <http://www.showssubmit.com/>
- ALL WORKS MUST BE FOR SALE: Artist commission 60%, NAWA – FL Chapter 10%, NAWA 10% and the Coral Springs Art Museum 20%. All sales from show must be through NAWA office.
- Price, title and dimensions of entered work cannot be changed, nor can work be substituted.

**SPECIFICS:**

- Maximum size for 2-D wall art work and wall sculpture no greater than 40” in any direction and may not exceed 50 lbs. Pedestals are available. Ceiling hung sculpture is not accepted.
- No sawtooth hangers. All works must be wired to gallery standards, able to support weight and must meet professional presentation standards as interpreted by the NAWA Exhibition Committee. NAWA reserves the right to refuse work not professionally presented.
- Plexiglas is required for all works on paper. Exception: pastels may be framed under glass.
- Unframed artwork must be finished on all sides.
- All work must remain on exhibit during the entire show.
- Label all entries on back, upper right corner using labels on this form.

**AWARDS:**

First Place, Second Place, Third Place, Judge’s Recognition

**DELIVERY/SHIPPING:**

Out-of-town artists must ship art work via UPS to the Coral Springs Museum of Art, to arrive between, September 6-10, 2018. Address Shipped artwork to: Coral Springs Museum of Art, NAWA Exhibition: **DAYDREAMING**, 2855 Coral Springs Drive, Coral Springs, Florida 33065.

**ENTRY AGREEMENT:**

The entry application & payment will serve as the entrants’ agreement to all conditions (including the waiver below) set forth in this prospectus. Entries will be disqualified for failure to follow these instructions.

## WAIVER

My entry into the exhibition entitled, “**DAYDREAMING**” to be held at the Coral Springs Museum of Art, 2855 Coral Springs Drive, Coral Springs, Florida 33065, applied through [www.showssubmit.com](http://www.showssubmit.com), binds me to the agreement as stated below, and to leave said artwork until the specified removal date on the prospectus.

In consideration of the display of my artwork, I hereby declare I am the owner and creator of the original artwork being submitted by me, both as the artwork’s physical manifestation and the copyright of artwork. I accept full responsibility for any casualty of any kind while in the National Association of Women Artists, Inc. (NAWA) Online Exhibition. I hereby waive any and all claims against the National Association of Women Artists, Inc., and also the Coral Springs Museum of Art, 2855 Coral Springs Drive, Coral Springs, Florida 33065, as well as their employees, officers, directors and committee personnel. Nevertheless, for the purpose of this agreement, I agree that the stated value of the artwork shall be One (\$1.00) Dollar, in the event of any loss or damage to the piece of artwork.

I agree to allow an image of my artwork being exhibited to be used without charge for advertising and/or promotion in the furtherance of the Exhibition, and for any purposes including without limitation traditional media, social media, website as well as public relations, prior to and/or after the Exhibition.

My work is available for sale at the price hereinbefore agreed. I agree that if my work is sold during the exhibition, I will pay NAWA FL Chapter 10%, NAWA National 10%, the Coral Springs Museum of Art 20%, and I will retain 60% of the selling price.

Point of release clause: the work on exhibition is considered part of the exhibition from point of delivery (either by hand or by mail) and until actual pick up/shipping after close of exhibition. NAWA retains the right of discretion to decide if artworks do not meet the requirements of our show standards, or contain any inflammatory or offensive materials. I understand that my work may not be hung if it fails to meet professional presentation standards (as determined by the Exhibitions committee), arrives damaged, differs significantly from the jpeg image submitted, is over the depth, width and height limit and (for wall sculpture) is above the weight, depth, width and height limits.

Labels: NAWA is a not-for-profit art organization, will not list anything other than the name of the artists, the title of the work, dimensions, medium and price on the labels.

In the event of a dispute with regard to this Waiver Agreement, we agree that all disputes must be adjudicated in a State Court in the County, City and State of New York (i.e. Manhattan), under the Laws of the State of New York, without regard to choice of Law rules.

Note: The use of the National Association of Women Artists, Inc.’s logo, without prior written permission is prohibited. The use of the registered Trademark Seal and the logo of the National Association of Women Artists, Inc. for any personal or business use on any documents, postcards, invitations, and other promotional materials and communications is a violation of law.

The letters NAWA may be used by regular juried members (i.e., not Associate or Student), after their names, on all artworks, signifying their membership.

Upon entering this competition, I agree to the policies of this Waiver.
