Eligibility: The show is open to active members of the First Coast Pastel Society. Members may submit up to three paintings for the juried FCPS Members' Show. Any outstanding fines for materials checked out and books overdue more than six months must be returned or replaced in order to be eligible to participate in this show.

Eligible Work: Only original dry pastels completed in the last two years are eligible. Work may not have been shown in previous FCPS Juried Member Shows. Work must be original and not copied from other artists or published materials. Work done under supervision (such as in a workshop) is not eligible. Mixed media must be 80% dry pastel. Paintings must be framed, under glass or Plexiglas, ready for hanging (with picture wire, no saw tooth hangers) and can be no larger than 40" including frame, in either direction. If matted, the mat should be white or a light neutral color (colored liners are acceptable). Nudes may be submitted; however, the gallery may reject any work it deems inappropriate.

Fees:

Fees will be paid through ShowSubmit in a secured system using credit card, debit card or PayPal account.

Fees for the 2019 Juried Members Show:

3 Entries - \$30.00

2 Entries - \$25.00

1 Entry - \$18.00

Entries: All entries will be made through the ShowSubmit system www.showsubmit.com. The site is easy to navigate and guides the artist through the entry process. Artists fill out an online form, create a unique login identity and submit un-retouched digital images in jpg format. Images must be 300 dpi resolution and no larger than 900 pixels on the longest side. Pictures must be cropped to show just the image, no mat or frame. The file name should be: the artist last name, first initial, and title. ie: Smith_M_ASummerDay.jpg. (It is the artist's responsibility to prepare the digital images according to show specifications. ShowSubmit will not resize or alter images).

Entries are Due by March 10, 2019. Contact Janelle Wagoner for entry questions (janellewagoner.com or 904-955-0945).

Submission of an entry form is a commitment to show. No paintings may be removed from the show prior to the close of the show. Notification of acceptance will be by email and accepted artist will receive Exhibition Labels via email.

Delivery of Paintings:

Accepted paintings for the juried show must be delivered to the Cultural Center at Ponte Vedra, 50 Executive Way Ponte Vedra Beach, FL 32082 (904-280-0614), between 10:00 A.M. and 2:00 P.M. Saturday, April 27, 2019. Shipped paintings must arrive by Wednesday, April 24, 2019, at the address listed under Shipped Paintings.

Shipped Paintings

Painting Preparation: Shipped paintings must be packed in sturdy packing cases designed for art work that are easily opened and can be easily repacked for return shipping. We recommend the corrugated boxes sold by **Airfloat Systems**, (1-800-445-2580) www.airfloatsys.com. We further strongly recommend Plexiglas be used, **not glass**. If the artwork arrives damaged, or with broken glass, you will be contacted immediately to discuss possible options.

Arrangements for shipping both TO and FROM the show are the sole responsibility of the artist and all charges **MUST BE PREPAID**. When preparing your artwork for shipping be sure to include a Pre-Paid Return Shipping Label with a bar code. The bar-code is necessary for the labels to be used as a return shipping document. Also, include a check for \$20 for handling (payable to **Janelle Wagoner**). The handling fee is for unpacking and storage of your painting, safe transportation to the gallery, and the repacking and transporting your painting back to UPS after the show. You will receive an exhibition label or labels with your acceptance notification. Please complete and attach to the back of your artwork.

Before sealing your shipping container remember to include:

- 1. A pre-paid return shipping label**
- 2. A check for \$20 payable to Janelle Wagoner for handling**
- 3. Attach your exhibition label to the back of your painting**

Awards: Over \$1,700 in prizes will be awarded. Prizes will be awarded for Best of Show, First, Second, and Third Place plus several Awards of Merit to be determined by the Judge. The prizes will consist of cash, merchandise or gift certificates from pastel suppliers.

She received her third IAPS Masters Circle point in 2018. Kathy is also an Artist member of the Salmagundi Club and a Fellow Artist member of the American Artists Professional League, both in New York. She has won numerous awards in national art shows and is a past President of the Pastel Society of Tampa Bay.

Sales: All sales will be handled by the Cultural Center. The Cultural Center will charge a 40% commission. The First Coast Pastel Society takes no commission. Prices shown on the entry must be the retail price; you may also list work as not for sale (NFS).

Liability: The First Coast Pastel Society and the Cultural Center at Ponte Vedra will take every reasonable precaution to safeguard your artwork from damage. However, they are not responsible for loss or damage to your paintings. We suggest you carry your own insurance if you are concerned about the lack of coverage.

Return of Work: All work must be picked up on June 17, 2019 at the Cultural Center (10 a.m.-2 p.m.) No work may be removed from the show prior to this date.
