Exhibition Details and Guidelines - Please read this prospectus carefully.

Eligibility:

- Open to all active (paid-up) Signature Members of PSNJ working in soft pastels (no oil pastels) to participate in this show.
- All entries must be predominately (80%) executed in soft pastels.
- Only **original** work, executed within the past five years and not previously exhibited in a PSNJ judged Show is eligible.
- All entries must be original, and created independently by the artist from his/her own original reference materials or setup. Work done in a classroom setting or workshop, under the guidance of an instructor or in an instructor's presence, is not eligible.
- Work may not be based on or directly derived from reference materials created or arranged by others, even if with permission, royalty-free, or not copyrighted.

Entry Requirements: There are no size requirements for this online exhibit. ***I understand that this registration is for the specific painting submitted. **False representation of art submitted to PSNJ juried exhibitions and/or violation of these guidelines may result in art removal and suspension of exhibition privileges for a period of up to two years.*

Fees: \$30, non-refundable, for 1 painting; \$35 for 2 paintings, \$40 for 3 paintings (Only 1 will be accepted.)

Registration: Entries and registration will be done online via www.showsubmit.com. The image should show only the painting, no mat or frame. **Image submitted must be 1200 pixels on the longest side with a resolution of 72 ppi/dpi and saved as a .jpg.** Images should be named Last Name_First Initial_Title.jpg (i.e. Gladstone_A_Connection.jpg). **** By registering with ShowSubmit you agree to accept all terms and conditions set forth in this prospectus.**
