WHERE and WHEN:

The Rochester Art Club 2020 Art Exhibition will go live online at RochesterArtClub.org Friday, November 12, 2021. The show will continue through Monday January 17, 2022.

Show Reception: A reception on Zoom will be announced via email.

JUROR:

Recognized for her expressive brushwork, contemporary compositions, and intelligent use of color, Nashville Tennessee native, **Lori Putnam** paints small to medium-sized works en plein air and creates large paintings in her studio. Having painted and taught in nearly 20 different countries (including Ukraine, New Zealand, Guatemala, much of Europe and the UK), she believes that works created from life help her maintain freshness in her studio paintings as well.

While she considers herself primarily self-taught, the advice and support of Scott Christensen, Quang Ho, and Dawn Whitelaw have been key to the artist's development and success. Lori has exhibited with many respected organizations including but not limited to the Salmagundi Club in New York City, the Oil Painters of America, Laguna Plein air Painters Association, the California Art Club, and the American Impressionists Society. Additionally, both Lori's plein air and studio paintings have received countless awards. Some of her more recent accolades have come from the Salmagundi Club in New York City, the Portrait Society of America, The American Impressionist's Society, the Oil Painters of America, All Along the Sierra Exhibition, National Oil and Acrylic Painters Society, and the Forgotten Coast Plein Air Invitational. In 2021 she took home the \$15,000 Grand Prize and the People's Choice Awards from Plein Air Salon.

When not traveling to paint, teach, or lecture, Putnam works in her studio in Charlotte, Tennessee.

ENTRIES:

- Please note that this year's Member show is juried for acceptance, as well as judged for awards.
- You may submit your digital images online at showsubmit.com.
- Up to 3 digital images are allowed.
- Show only the artwork, no frame.

- A non-refundable entry fee of \$10 per entry is required. This entry fee is paid via credit or debit card through showsubmit.com.
- DEADLINE for entry is midnight on Friday, October 22, 2021.
- Images should have a minimum of 1600 pixels on the longest side, with a resolution of 72 dpi/ppi.
- The file must be saved in high quality .jpg format, with the file name consisting of the artist's last name, underscore, first initial, underscore, painting title, .jpg. (For example: Jones_D_Summer Fun.jpg.) The title may be abbreviated if necessary.
- Medium and size are information you can add during the entry process.

RULES OF ENTRY:

- Associate members ARE eligible to enter this exhibit
- All entrants must be a member in good standing as of September 30, 2021.
- Entries must have been created within the last two years and may not have been shown at any previous RAC or other juried show within Monroe County.
- All aspects of the entry must be the artist's original work including subject, photography, composition, drawing and painting. Using a photo as reference taken by another person, or copying another painting or magazine picture, EVEN WITH PERMISSION, is not considered original work. If you are uncertain as to whether your piece is original, please contact us before submitting at rochesterartclub437@gmail.com
- Entries may not be produced in any instructional class or workshop.
- No diptych or triptych paintings, mechanical reproductions, photography, crafts or computer generated art.
- 3-D art is acceptable for this show.
- Nudes are acceptable for this show.
- There is no limit on size.

The artist grants permission to reproduce work for digital publicity purposes. Copyright will be attributed to the artist. Entry into this exhibition constitutes agreement with all conditions set forth in the prospectus and entry form and is your commitment to participate.

AWARDS:

Best of Show Award (\$100 cash), Rochester Art Supply Award (\$50 gift card), six Juror Awards (\$50 cash), and six Merit Awards (\$25 cash). Only one award per member is allowed.

SALES:

All sales of artworks are to be handled by the individual artist. Any purchase inquiries will be channeled through the RAC's email and forwarded to the artist. The artist is responsible for deciding whether to include shipping costs and/or any applicable sales tax in the price listed. The artist handles the packaging and shipping and agrees to ship the art within 10 days of purchase.
